

**SUMMARY ANNUAL REPORT  
FOR  
ELEVATOR CONSTRUCTORS ANNUITY AND 401(K) RETIREMENT PLAN**

This is a summary of the annual report for the Elevator Constructors Annuity And 401(k) Retirement Plan, EIN 52-2125995, Plan No. 001, for the period January 1, 2017 to December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the Plan are provided through a trust fund. Plan expenses were \$80,287,843. These expenses included \$2,613,514 in administrative expenses and \$77,674,329 in benefits paid to participants and beneficiaries. A total of 32,383 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$3,358,865,347 as of December 31, 2017 compared to \$2,671,581,064 as of January 1, 2017. During the Plan year the Plan experienced an increase in its net assets of \$687,284,283. This increase includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The Plan had total income of \$767,632,207, including employer contributions of \$263,844,428, employee contributions of \$90,795,394, rollover contributions of \$3,338,164, earnings from investments of \$409,557,452 and other income of \$96,769. The Plan also received transfers of assets from another plan of \$21,504 and transferred assets of \$81,585 to this same plan.

7. fiduciary information, including non-exempt transactions between the Plan and parties-in-interest (that is, persons who have certain relationships with the Plan)

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. These portions of the report are furnished without charge.
