SUMMARY ANNUAL REPORT FOR NATIONAL ELEVATOR INDUSTRY HEALTH BENEFIT PLAN

This is a summary of the annual report for the National Elevator Industry Health Benefit Plan, EIN 23-2790911, Plan No. 501, for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

National Elevator Industry Health Benefit Plan Board of Trustees has committed to pay certain hospitalization, major medical, surgical, dental, medical, prescription, mental health, alcoholism and substance abuse, vision and hearing claims incurred under the terms of the Plan.

Insurance Information

The Plan has contracts with The Union Labor Life Insurance Company, Amalgamated Life Insurance Company, and Carelon Behavioral Health to pay certain life insurance, weekly income, accidental death & dismemberment, and employee assistance program claims incurred under the terms of the Plan. The total premiums paid for the Plan year ended December 31, 2023 were \$6,392,748.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$2,932,266,437 as of December 31, 2023 compared to \$2,630,045,661 as of January 1, 2023. During the Plan year the Plan experienced a gain in its net assets of \$302,220,776. This increase includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$1,299,673,481, including employer contributions made on behalf of employees of \$820,148,405, employee contributions of \$91,595,998, gain of \$6,861,787 from the sale of assets, earnings (loss) from investments of \$277,080,624 and other income of \$103,986,667.

Plan expenses were \$997,452,705. These expenses included \$24,284,377 in administrative expenses, \$26,581,850 in benefit administration, provider network and related fees, and \$946,586,478 in benefits paid to participants and beneficiaries.
